SUBJECT: **14<sup>TH</sup> REGIONAL SCOUT JAMBOREE**

1. This is to announce that the Boy Scouts of the Philippines, Eastern Visayas Region will hold the **14<sup>th</sup> Regional Scout Jamboree** on **April 25-30, 2024** at **YOCENCA, Naparaan, Salcedo, Eastern Samar**.
2. **This Jamboree aims** to provide a progressive, exciting, challenging, safe and enjoyable learning environment for the Scouts in order to enhance their full Social, Physical, Intellectual, Character, Emotional, Spiritual Potentials and camaraderie where they will learn to work together as active citizens making real contributions in creating a better community.
3. **Qualification for Participation.** The following are the qualifications for all participating Scouts and and Adult Leaders:

#### A. Boy Scouts and Senior Scouts

1. Must be currently registered as Boy Scout, Senior Scout with a Troop or Outfit;
2. Physically fit to undergo strenuous activities especially in the outdoors as certified by a licensed Physician;
3. Shows leadership potential in his/her Unit and preferably a graduate of PLTC/CLTC;
4. Must be between nine (9) to twelve (12) years old for Boy Scouts;
5. Must be between thirteen (13) to eighteen (18) years old for Senior Scouts;
6. Secure his/her Parent's/Guardian's Consent; and
7. Must have his/her own camping gears and equipment.

#### B. Rover Scouts

1. Must be currently registered with a Rover Circle in good Standing;
2. Must be between eighteen (18) to twenty-six (26) years old; and those who are in Senior High School in the Rover Scouting Section;
3. Must have Health and Medical Certificate to be physically fit as certified by a Licensed Physician; and
4. Must have complete set of Camping Gears and Equipment.

#### C. Adult Leaders and Rover Leaders

1. Must be of good moral character;
2. Must be currently registered as **Troop Leader, Outfit Advisor, or Rover Leader**;
3. Must be physically fit as certified by a Licensed Physician;
4. Must be a graduate of a Basic Training Course for Troop Leader/Outfit Advisor;
5. Preferably a Wood Badge Holder; and
6. Must be equipped with camping gears.

4. A Jamboree fee of **FIVE HUNDRED PESOS (P500.00)** shall be charged each participant to defray expenses for the program materials, certificates, souvenirs and other administrative costs. An advance registration of **THREE HUNDRED PESOS (P300.00)** to be used for early purchase of materials and souvenirs must be paid directly to the host Council, Eastern Samar Council via bank transfer not later than March 22, 2024, with the following details:

Registration fee is non-refundable but transferable. Photocopy or scanned copy of deposit slip must be submitted to the host Council via email at [alvin.jocosol@gmail.ph](mailto:alvin.jocosol@gmail.ph) and to the Regional Office at [bsp.evrco@scouts.gov.ph](mailto:bsp.evrco@scouts.gov.ph).

5. Registration, transportation and other incidental expenses on this travel may be charged against **scouting funds/local funds/MOOE/SEF** subject to its availability and the usual accounting and auditing rules and regulations.
6. The standard camping equipment as prescribed in activities of this nature should be brought by every contingent. Scouts must cook their own meals. All contingents are expected to have adequate food supply to last for the duration of the Jamboree.
