Greetings!

The Expanded Regional Advisory Committee successfully conducted the 3rd Quarter Meeting 2023 last October 5 and the Field Visit in the Municipality of Minglanilla last October 6, 2023.

Based on the observations and recommendations of various institutional partners and other Pantawid Staff during the field visit at Minglanilla Central School in Cebu, we have found out that there were school activities where only 4Ps beneficiaries participated.

In line with this, may we ask your help to reiterate to all our school facilities that as much as possible, we encourage the integration of the 4Ps beneficiaries to all activities participated by all parents and not just by 4Ps beneficiaries, especially in the provision of a safe and healthy environment for the students.


