PROPOSED RESTORATION AND CONSERVATION OF GABALDON BUILDING AT DR. CECILIO PUTONG NATIONAL HIGH SCHOOL

1. The **Department of Education, Division of City Schools - Tagbilaran City**, through the **Basic Education Facilities Fund - CY 2024** intends to apply the sum of **Twenty Four Million Two Hundred Twenty Two Thousand Three Hundred Twenty Two Pesos and Seventy Seven Centavos (Php 24,222,322.77)** being the Approved Budget for the Contract (ABC) to payments under the contract of the **Proposed Restoration and Conservation of Gabaldon Building at Dr. Cecilio Putong National High School**. Bids received in excess of the ABC shall automatically be rejected at bid opening.
2. The **Department of Education, Division of City Schools - Tagbilaran City** now invites bids for the above Procurement Project. Completion of the Works is required within the period of **270 Calendar Days**. The participating bidders must have an experience in the conservation and restoration of Gabaldon School Buildings. They are required to attach the NOA, Contract, NTP and Certificate of Completion as proofs of their experience. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
3. Bidding will be conducted through open competitive bidding procedures using non-discretionary “*pass/fail*” criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
4. Interested bidders may obtain further information from **Department of Education, Division of City Schools - Tagbilaran City** and inspect the Bidding Documents at the address given below during office hours (**8:00 am to 5:00 pm**).
5. A complete set of Bidding Documents may be acquired by interested bidders starting **March 11, 2024 to April 5, 2024** from address below and upon payment in cash of a nonrefundable fee of the Bidding Documents in the amount of **Twenty Five Thousand Pesos Only (Php 25,000.00)**.
6. The **Department of Education, Division of City Schools - Tagbilaran City** will hold a Pre-Bid Conference on **March 21, 2024 @ 10:00 am** at **Bohol Bee Farm, Dao, Dauis, Bohol**, which shall be open to prospective bidders.
7. Bids must be duly received by the BAC Secretariat at the office address as indicated below, on or before **April 5, 2024, until 8:59 am**. Late bids shall not be accepted.
