**UPGRADING/MODERNIZATION OF ELECTRICAL SYSTEM AT MANSASA
ELEMENTARY SCHOOL**


1. The **Department of Education, Tagbilaran City Division**, through the **Basic Education Facilities Fund (BEFF) - CY 2024** intends to apply the sum of **Five Million Nine Hundred Forty-Six Thousand Five Hundred Sixty-Three Pesos and Six Centavos (Php 5,946,563.06)** being the Approved Budget for the Contract (ABC) to payments under the contract for **Upgrading/Modernization of Electrical System at Mansasa Elementary School**. Bids received more than the ABC shall be automatically rejected at bid opening.
2. The **Department of Education, Tagbilaran City Division** now invites bids for the above Procurement Project. Completion of the Works is required **90 Calendar Days**. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders). Furthermore, prospective bidders on the above-mentioned project should be a licensed contractor of the Philippine Contractors Accreditation Board (PCAB) with registration particulars **SP-EE (Electrical Work)** Minimum Category A.
3. Bidding will be conducted through open competitive bidding procedures using non-discretionary "*pass/fail*" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
4. Interested bidders may obtain further information from **Department of Education, Tagbilaran City Division** and inspect the Bidding Documents at the address given below during office hours (8:00am to 5:00pm).
5. A complete set of Bidding Documents may be acquired by interested bidders starting **November 8, 2023, to November 29, 2023**, from address below and upon payment in cash of a nonrefundable fee of the Bidding Documents in the amount of **Ten Thousand Pesos Only (Php 10,000.00)**.
6. The **Department of Education, Tagbilaran City Division** will hold a Pre-Bid Conference on **November 17, 2023 @10am** at **DepEd, Tagbilaran City Division, Conference Hall** which shall be open to prospective bidders.

7. Bids must be duly received by the BAC Secretariat at the office address as indicated below, on or before **November 29, 2023, until 8:59am**. Late bids shall not be accepted.
8. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB Clause 16**.
9. Bid opening shall be on **November 29, 2023, 9:00am** at **DepEd, Tagbilaran City Division, Conference Hall**. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.

The **Department of Education, Tagbilaran City Division** reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised Implementing Rules and Regulations (IRR) of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.


