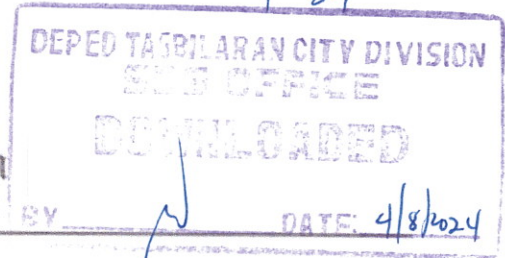

**SUSPENSION OF CLASSES IN CEBU ISLAND DUE TO HIGH HEAT INDEX AND
SHIFT TO ALTERNATIVE DELIVERY MODE**

To: Schools Division Superintendents in Cebu Island

1. Due to the high heat index experienced by the Island of Cebu, posing a risk to the well-being of the students, **all face-to-face classes in schools within Cebu Island are suspended today until further notice.**
2. All schools are advised to shift to Alternative Delivery Mode. The concerned Schools Division Offices, through the Schools Division Superintendents, shall monitor schools implementing the modality and shall submit a report to the Regional Office.
3. This decision is in line with the declaration of the Office of the Governor of the Province of Cebu for the suspension of classes and the DepEd Order No. 37, s. 2022 and Memorandum OUOPS No. 2024-04-02477.
4. Moreover, school heads are reminded of their authority and responsibility, to suspend in-person classes and implement modular distance learning in cases of unfavorable weather environment such as, but not limited to, extreme heat which poses health risks hindering learning and productivity.
