The Bidding Conference was called to order by BAC Chairperson Dr. John Ariel Lagura as the Presiding Officer at 09:00 o'clock in the morning. It started with a prayer by Dr. Ma. Antonette Dugang. The Presiding Officer declared the meeting quorum after a roll call of the BAC members made by Elaine Centino, Secretariat Chair.

55 **A. MAIN AGENDUM**

- 56 1. Proposed Restoration and Conservation of Gabaldon
57 Building at Dr. Cecilio Putong National High School

59 After the Presiding Officer acknowledged again the presences of the
60 bidders, the bidding process then proceeded. The sealed envelopes
61 of the bid documents were opened. The checking of the technical,
62 legal, and financial aspects of the bid documents by the BAC
63 Members was undertaken.

64
65 The Presiding Officer directed to open the technical documents of
66 the two (2) bidders. It was chronologically open based on the
67 sequence of who dropped the bid documents first, as follows: C.
68 Jansen Construction and General Merchandise, then Dolci
69 Construction and General Merchandise.

70
71 With an Approved Budget Contract of Twenty four million two
72 hundred twenty two thousand three hundred twenty two pesos &
73 77/100 (Php 24,222,322.77), the bid amounts of the bidders per
74 financial documents submitted were Twenty four million two
75 hundred two thousand two hundred seventy one pesos & 24/100
76 (Php 24,202,271.24) for C. Jansen Construction and General
77 Merchandise and Twenty four million two hundred eleven
78 thousand nine hundred fifty four pesos & 04/100 (Php
79 24,211,954.04) for Dolci Construction and General Merchandise.

81 The Presiding Officer then announced after checking all the
82 documents that the bidders were eligible. He read again the bid
83 amounts of both bidders, with C. Jansen Construction and General
84 Merchandise as the lowest.
