YAP, CITY MAYOR OF THE CITY OF TAGBILARAN, TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE DEPARTMENT OF EDUCATION CITY SCHOOLS DIVISION - TAGBILARAN CITY (DepEd-Tagbilaran), FOR THE COLLECTION OF USED COLORED SINGLE-USE CELLOPHANES AND PLASTIC BAGS AND PROMOTE RECYCLING AND UPCYCLING

WHEREAS, Republic Act 9003, otherwise known as the Ecological Solid Waste Management Act of 2000, provides the policy of the State to adopt a systematic, comprehensive and ecological solid waste management program which utilize environmentally-sound methods that maximize the use of valuable resources and encourages resource conservation;

WHEREAS, the City Government and the Department of Education City Schools Division-Tagbilaran City recognize the importance of waste management and is committed to promoting environmental awareness and sustainability in the households and schools in the community;

WHEREAS, the City Government and DepEd-Tagbilaran shall collaborate on a project to collect used colored single-use cellophanes and plastic bags and recycle and upcycle them into valuable and useful products;

WHEREAS, this project shall raise environmental awareness and help reduce the volume of liter generated by local communities that end up in canals, waterways, rivers, streams, and eventually to the sea, causing danger to marine life;

WHEREAS, the Memorandum of Agreement outlines the terms and condition and the obligations of each party for the smooth and efficient implementation of said program;

WHEREAS, the City Mayor, as cited under Sec. 455 (b)(vi) of Republic Act 7160, shall represent the city in all its business transaction and sign on its behalf all bonds, contracts, and obligations and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinance;

NOW THEREFORE, Be It Resolved, As It Is Hereby Resolved by the Fifteenth Sangguniang Panlungsod of the City of Tagbilaran in session duly assembled:
