TITLED DIVISION DANCE SPORTS WORKSHOP FOR ELEMENTARY DANCERS**

1. After the successful conduct of the Dance Sports Workshop for Elementary Dancers last July 3-31, 2024 at the Tagbilaran City Central Elementary School Covered Court duly handled by Mr. Triffon Dollente during Mondays, Wednesdays and Fridays from 8:00-12:00 and 1:00-5:00 PM.
2. It is reiterated in this memorandum that a registration fee of six hundred pesos (600 Php) per dancer is collected for the Professional Fee of the Dance Instructor chargeable against School MOOE and other Local Funds subject to the usual accounting and auditing rules and regulations of the government.
3. Teacher Coach who religiously attended the Dance Workshop is afforded with service credits with sufficient evidence of actual attendance on the said training to guide and look after the welfare of their dancers. As a culmination of the Dance Sports Workshop a dance recital is scheduled on Saturday August 17, 2024 from 9:00-12:00 NN at the Tagbilaran City Central Elementary School Covered Court. In relation thereto, a general rehearsal is scheduled on August 16, 2024 from 3:00-5:00 PM @ the TCCES CC.
4. All other provisions of Division Memorandum No. 414 is still enforced.

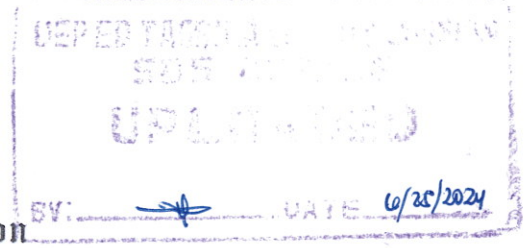

This Office hereby announces the conduct of the Division Dance Sports WorkShop on July 3-31, 2024 at Tagbilaran City Central Elementary School Covered Court with Mr. Triffon Dollente as the Dance Instructor. Dance Sports Sessions will be held on Monday, Wednesday and Friday from 8:00-12:00 noon and 1:00-5:00 pm.
2. Participants to this Dance Sports Workshop are 2 pairs (4) young elementary dancers preferably grades 3 and 4 learners; 1 pair for the Modern and 1 pair for the Latin dances.
3. School Heads are advised to provide 1 coach for the dancers to guide and ensure their safety and security during the duration of the dance workshop. Parents consent should be secured from the participants and to be submitted to the dance instructor through the coach.
4. Expenses relative to the conduct and participation of the said dance workshop like transportation, meals and snacks and costume of participants and PF of the dance instructor are chargeable against school MOOE and other local funds subject to the usual accounting and auditing rules and regulations of the government.
