Additionally, the safety of all participants must be given utmost consideration in the conduct of the activity. The girls must have permission from their parents/guardians (*Attachment - Parent's Consent Form*).

### Suggested and Possible Activities

Handcrafts, Arts, Nature Lore, Community Service, Hikes, Song and Dance, Sports, Games (Scout Games, Wide Games, Team Games, Singing Games), Tree/Mangrove Planting, Non-Utensil Cooking, Anti-Dengue Campaign, Membership Campaign, Girl Scouts Got Talent, and Mutya ng Girl Scout (Twinkler or Star).

Activities under the GSP Eight-Point Challenge Program; activities of the programs on Free Being Me (FBM), Action on Body Confidence (ABC), Girl Powered Nutrition (GPN), Stop the Violence (STV); and Sustainable Development Goals (SDG).

### Service Credit/Compensatory Overtime Credit (COC)

Adult leaders are entitled to a Service Credit or a Compensatory Overtime Credit (COC), whichever is applicable.
