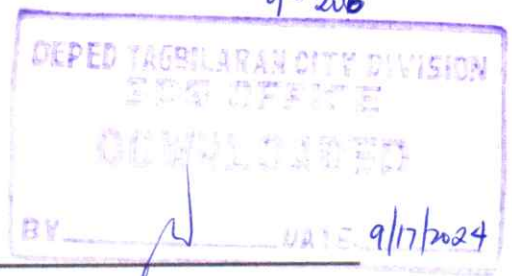

May we further request for a feedback with regards to the schools' schedules if they are amenable to it so as not to disrupt the classes and in such manner will give us ample time for the preparation.


