



*(Sponsored by: Hon. Gemma M. Inting, City Councilor)*

**WHEREAS**, the Department of Education (DepEd) and the Department of Social Welfare and Development (DSWD), in consultation with other National Government Agencies (NGAs), Local Government Units (LGUs), Non-Government Organizations (NGOs), and development partners, are mandated by Republic Act No. 11037, also known as "Masustansyang Pagkain Para sa Batang Pilipino," to establish rules and regulations for the efficient and effective implementation of feeding programs in public daycare centers, public kindergarten, and elementary schools. This mandate is outlined in Section 4 of the law, which aims to address undernutrition among Filipino children;

**WHEREAS**, the City Government of Tagbilaran, in compliance with the mandate of the national government, has established the Supplemental Feeding Program (SFP) to address the nutritional needs of pupils;

**WHEREAS**, the SFP aims to provide additional food to all enrolled pupils in elementary and special education (SPED) schools in Tagbilaran City, as part of the broader effort to combat malnutrition and promote children's health and well-being;

**WHEREAS**, the SFP seeks to improve the nutritional health of pupils, encourage regular school attendance, and promote proper nutrition;

**WHEREAS**, the SFP is designed to address hunger and food security issues among Filipino children, thereby preventing any decline in the current nutritional status of the beneficiaries;

**WHEREAS**, the success of this program relies on the coordination, cooperation, and a unified strategy between the Local Government Unit of Tagbilaran and the Department of Education through the Tagbilaran City Schools Division;

**NOW THEREFORE**, Be It Resolved, As It Is Hereby Resolved by the Fifteenth Sangguniang Panlungsod of the City of Tagbilaran in session duly assembled:





**REQUESTING THE HONORABLE CITY MAYOR JANE CENSORIA C. YAP TO GRANT TEMPORARY SPECIAL PERMITS TO VARIOUS TRANSPORT GROUPS TO PLY THE ROUTES TO CABAWAN DR. CECILIO PUTONG NATIONAL HIGH SCHOOL (DCPNHS) CAMPUS TO SERVE THE TRANSPORTATION NEEDS OF STUDENTS AND EMPLOYEES THEREOF**

*(Sponsored by: Hon. Jonas R. Cacho, City Councilor)*

**WHEREAS**, Section 5, Article XIII of the 1987 Philippine Constitution states that “the state shall take into account regional and sectoral needs and conditions and shall encourage local planning in the development of educational policies and programs”;

**WHEREAS**, Section 17, 4(1) Book I of Republic Act 7160 provides that all services and facilities of the City should provide adequate communication and transportation facilities;

**WHEREAS**, presently only four (4) transport groups, authorized by the Land Transportation Franchising and Regulatory Board (LTFRB), are plying the Barangay Cabawan route which is not enough to service the transportation needs of the people residing and studying in DCPNHS Barangay Cabawan;

**WHEREAS**, Dr. Cecilio Putong National High School Cabawan Campus has 1,200 students and around 100 employees that need transportation service going to school and going home after school;

**WHEREAS**, a special permit for these transport groups will be of immense help in complementing the existing limited routes of these four (4) LTFRB accredited transport groups and answer the dire need of these students and employees;

**WHEREAS**, in the recent meeting of the Committee on Energy, Public Utilities, Franchises and Transportation last September 17, 2024 at the SP Session Hall, Committee Members have unanimously agreed to recommend the following Transport Groups to be granted temporary special permits with five (5) units each, to wit:

1. DATODA TRANSPORT CORP.- proposed route from CITY SQUARE - J.A. CLARIN ST. – ICM-IBT-COOP HOSPITAL-BINAYRAN ROAD TO DCPNHS CABAWAN and vice versa
2. BOHOL TRANSPORT COOPERATIVE – proposed route from PLAZA RIZAL-MANGA-CABAWAN DCPNHS via TIPTIP (ESABO ROAD)
3. TAJETCO – proposed route from LINDAVILLE PHASE 2-SAN ISIDRO-DCPNHS CABAWAN and vice versa


