





Training costs, which cover the venue, accommodation, and meals, shall be charged against LGU-CYDO Funds, while travel expenses of the participants shall be charged to local funds/school MOOE/ALS TTA, subject to the usual accounting and auditing rules and regulations prescribed by the Commission on Audit.
5. Related-Teaching and Non-Teaching Staff shall be provided with Service Credits/Compensatory Time-Off (CTO) per Civil Service Commission and Department of Budget and Management Joint Circular No. 2, s. 2004 on Non-Monetary Remuneration for Overtime Services Rendered.
