
The key components for initiating the cascading of the program with SDRRT are as follows:

1. **Establishment of Region 7's Pool of SDRRT:** Selected DepEd personnel will form the Pool of SDRRT in the region. Their expertise will be instrumental in disseminating best practices and building capacity among educators and students.
2. **Conduct of Regional Training of Trainers (RToT):** RToT will be organized during the second week of January 2025. SDRRTs will actively participate in this training, equipping them with the necessary skills to lead the School-based DRR Training Program.

For your reference, we have attached our proposal on the selection criteria and process of SDRRT (please refer to ANNEX 1-6).

SEEDS Asia Proposal:

Guidelines on the selection of School Disaster Risk Reduction Trainer (SDRRT) and participation to RToT (to be issued through the regional memorandum)

Contents in the RM:

1. DepEd RO7 ESSD with HRDD will conduct Regional Training of Trainer (RToT) for the establishment of School Disaster Risk Reduction Trainer (SDRRT) on (Month) (Date), 2024, (Time) at (Venue).
2. The following may apply;
 - A) Permanent **non-teaching or teaching-related personnel** having PRC License for Professional Teacher, preferably School Heads;
 - B) Physically fit and preferably 55 years old and below;
 - C) Must have obtained Master's Degree or above;
 - D) Must have been trained as trainers/facilitators;
 - E) **Must have competent skills and experience in making NEAP-level standard Session Guides** and Slide Deck;
 - F) Must have a performance rating at least VS for the last two years;
 - G) Must be computer literate;
 - H) Must have participated or facilitated any trainings on disaster risk reduction (e.g. DepEd 23 DRRM Module, Contingency Planning, etc.); and
 - I) **Must have strong willingness to become SDRRT** who will contribute to provision of DRR training at school level for five years
3. Applicants should submit personally to the SDO-HRD the following documents by (Deadline):
 - A) Endorsement from the Schools Division Superintendent
 - B) Application Form (Annex 1) ***same format with the NEAP Pool**
 - C) Character Reference (Annex 2) ***same format with the NEAP Pool**
 - D) Medical certificates from accredited government physician/hospital indicating physical fitness to train and travel
 - E) Performance rating for the past two years
 - F) Letter of recommendation from immediate supervisor (Annex 3) ***same format with the NEAP Pool**
 - G) Letter of commitment signifying willingness to training anywhere in the Region 7 (Annex 4) ***same format with the NEAP Pool**
 - H) Certificate of no pending criminal and/or administrative cases from the Division
 - I) Certificate of participation/completion/attendance to Training of Trainers program attended
 - J) Certificate of recognition/commendation/merit/etc, given as facilitator, trainer, resource speaker, etc. or a certification from immediate supervisor that the individual acted as

facilitator/resource speaker if there are no certificates from clients. There certificates should support the list provided in the application form.

4. In the view of above, SGOD Chiefs/HRD Chiefs shall conduct an initial screening applicants following the Screening Rating Guide (Annex 5), and endorse the top 8 qualified applicants to the Regional Screening Committee following the template below on or before (Deadline).
