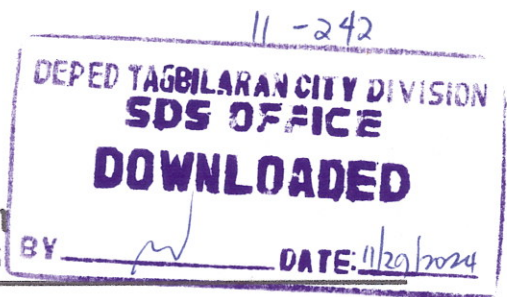



The Regional Offices (ROs) and Schools Division Offices (SDOs) are hereby reminded to **process the payment of Teaching Overload** to eligible teachers for Fiscal Year (FY) 2024 with reference to DepEd Order (DO) No. 005, s. 2024, *Rationalization of Teachers' Workload in Public Schools and Payment of Teaching Overload*, and DepEd Memorandum (DM) No. 053, s. 2024, *Implementation Guidelines for DepEd Order No. 005, s. 2024*.

Based on the Summary of Appropriations, Allotments, Obligations, Disbursements, and Balances by Object of Expenditures (SAAODBE) as of 3rd Quarter of FY 2024, **only 3,667,321.75 (0.58%) of the total adjusted allotment has been obligated.** Kindly see Annex A for the Regional Breakdown.

The SDOs shall ensure that schools within their jurisdiction are able to **submit all necessary documents** for the payment for teaching overload in time for the deadline of obligation of funds. Further, the SDO-Administrative Unit (Personnel Section) and SDO-Finance Unit shall set the deadline for submission of requirements and ensure that schools are aware of such deadlines.

With the issuance of DO 005, s. 2024 and DM 053, s. 2024, it is expected that the field offices and schools will be able to expedite the processing of payment for teaching overload to eligible teachers.
