PROPOSED REPAIR OF CLASSROOMS, CLEAN-UP AND CLEARING OPERATIONS, CONSTRUCTION OF (3) THREE TEMPORARY LEARNING SPACES (TLS) FOR COGON NATIONAL HIGH SCHOOL

1. The **Department of Education, Division of City Schools - Tagbilaran City**, through the Current Appropriations, Disaster Preparedness and Response Program Fund - FY 2024 GAA intends to apply the sum of **One Million One Hundred Forty Three Thousand Four Hundred Fifty One Pesos (Php 1,143,451.00)** being the Approved Budget for the Contract (ABC) to payments under the contract of the **Proposed Repair of Classrooms, Clean-up and Clearing Operations, Construction of (3) Three Temporary Learning Spaces (TLS) for Cogon National High School**. Bids received in excess of the ABC shall automatically be rejected at bid opening.
2. The **Department of Education, Division of City Schools - Tagbilaran City** now invites bids for the above Procurement Project. Completion of the Works is required within the period of **30 Calendar Days**. Bidders should have completed a contract similar to the project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
3. Bidding will be conducted through open competitive bidding procedures using non-discretionary “*pass/fail*” criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
4. Interested bidders may obtain further information from **Department of Education, Division of City Schools - Tagbilaran City** and inspect the Bidding Documents at the address given below during office hours (**8:00 am to 5:00 pm**).
5. A complete set of Bidding Documents may be acquired by interested bidders starting **November 5-25, 2024** from address below and upon payment in cash of a nonrefundable fee of the Bidding Documents in the amount of **Five Thousand Pesos Only (Php 5,000.00)**.
6. The **Department of Education, Division of City Schools - Tagbilaran City** will hold a Pre-Bid Conference on **November 14, 2024 @ 10:00 am** at **DepEd Division of City Schools-Tagbilaran City Conference Hall**, which shall be open to prospective bidders.

The **Department of Education, Division of City Schools - Tagbilaran City** reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 Revised Implementing Rules and Regulations (IRR) of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
