**ORIENTATION ON POSITIVE DISCIPLINE LEARNING ACTION CELL (LAC)
SESSION GUIDES**

1. This Office, through the Education Support Services Division – Learner Rights Protection Office (LRPO), will conduct an Orientation on Positive Discipline Learning Action Cell (LAC) Session Guides for the primary purpose of strengthening Department Order No. 40, s. 2012 or the DepEd Child Protection Policy that prohibits the use of corporal punishment and encourages the use of a non-violent approach to discipline. The said activity shall be held on **April 23-25, 2025** at **DepED Ecotech Center, Sudlon, Lahug, Cebu City**.
2. Participants to this activity are the School Head, representative from the Curriculum Implementation Division, Education Program Supervisor and Teacher Representatives. The identified participants **will be expected to serve as discussants in cascading the lessons** to their respective divisions, districts and schools.
3. The objectives of this training are the following:
 - a. To know and understand the DepEd policies, program and issuances related to Learner's Rights and Protection;
 - b. Aims to develop the necessary skills in providing timely and appropriate actions (discipline or intervention) and resources in managing and handling incidence of serious and complex LRP-related cases;
 - c. Aims to equip the participants with the required knowledge, skills and attitude in providing appropriate positive discipline;
 - d. Overall, to strengthen the use of positive discipline as behavioral management technique in schools.
4. The check-in of the participants shall be on **April 23, 2025 (Wednesday) at 12:00 Noon**, with the first meal to be served being the **Lunch**, while check-out shall be on **April 25, 2025**, with the last meal to be served being the **AM Snacks**.
5. Travelling and other related expenses of the participants shall be charged against their local/School/Division funds or the Regional LRP-PSF, if available subject to the usual accounting and audit rules and regulations.
