1. In support of the implementation of Project BRIDGE (Building Responsive Instructional Designs for Growth and Equity) under the CLMD-initiated SHARE, this Office, through the Curriculum Implementation Division (CID), shall conduct a two-day **Division Refinement Writeshop of the Developed Araling Panlipunan Instructional Plans (iPlans) for Inclusive and Multigrade Classes Under BRIDGE of CLMD Project SHARE** on July 17-18, 2025.  - a) review and evaluate the developed Araling Panlipunan iPlans for alignment with the K to 12 curriculum standards and competencies;

 - c) ensure the alignment of the iPlans with the goals of Project BRIDGE under CLMD Project SHARE framework.
