





BATCH 2 PARTICIPANTS**

DATE : July 23, 2025

1. Basic Life Support – CPR Training equips school personnel with essential skills to respond to cardiac and breathing emergencies. It includes hands-on CPR and Automated External Defibrillator use, ensuring timely and effective care in school-based scenarios.
2. In line with this, the Office, in partnership with the Department of Health and the Tagbilaran City Disaster Risk Reduction and Management Office (CDRRMO), will conduct Basic Life Support – CPR Training (Batch 2) on July 31–August 1, 2025, at JJ's Seafood Village, Poblacion II, Tagbilaran City, Bohol.
3. All concerned personnel are hereby directed to attend and actively participate in the said training. Teaching personnel who will be participating are required to prepare and submit a catch-up plan to their respective school heads to ensure that any missed instructional time during the two-day training is adequately addressed.
4. Food and other incidental expenses incurred during the training shall be charged against the Division Disaster Preparedness and Response Program (DPRP) funds, subject to the usual government accounting and auditing rules and regulations.
