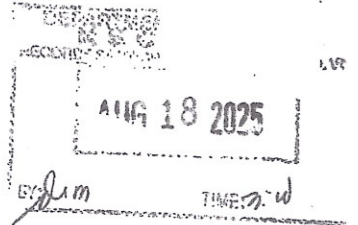



Our goal is to enhance the Filipino, National Core Values of being MAKADIOS, MAKABANSA, MAKATAO, and MAKAKALIKASAN.


