2. This year's tournament will be hosted by Lapu-Lapu City Division. The opening will be on June 12, 2026 (Friday/Holiday) at Lapu-Lapu City. It will start with the registration, followed by a simple parade, short program, search for Mr., Ms. & Queen DERESA 2026 and game proper in the afternoon. Each team shall be responsible of their own provisions. The host division will be providing billeting quarters only.

3. All participating teams are required to attend the parade and opening program. A minor award will be given to the division garnering the highest number of athletes during the parade and the opening program.

4. During the Registration, the team shall submit the credentials required placed in a folder:
 - a. Official line-up;
 - b. Medical Certificate;
 - c. Certificate of employment;
 - d. Photocopy of appointment of the teacher-player;
 - e. DepEd I.D photocopy; and
 - f. Duly accomplished DERESA membership form.

5. Registration fee of Php 800.00 per player per event and membership fee of Php 200.00 per player shall be paid on or before June 12, 2026 through our DERESA treasurer.

6. International Basketball Federation (FIBA), International Volleyball Federation (FIVB), Lawn Tennis, Chess, Billiard, Badminton, Sepak Takraw, and Table Tennis Rules and Regulations shall be followed respectively. However, the committee can modify the rules provided that these rules will be presented and agreed upon and duly signed by the participating team's coach or by the head of the delegation.


7. The registration fee, uniform, transportation expenses and other expenses related to these activities shall be charged against **School GAD Fund/Division MOOE/SEF/PTA/GAD** or other funds, subject to usual accounting and auditing rules and regulations.
