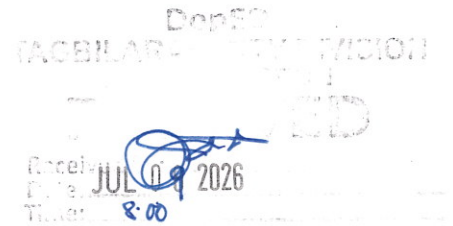

Registration Fee

A minimal registration fee of Two Hundred Pesos (P 200.00) per participant shall be collected to cover the cost of lunch and one snack. The Council shall shoulder the expenses for the meeting materials.

The registration fee and transportation expenses of the DFA may be charged to the Maintenance and Other Operating Expenses (MOOE), Special Education Fund (SEF), or any other available source of funds, subject to the approval of DepEd Bohol and DepEd Tagbilaran City Divisions, and in accordance with the usual accounting and auditing rules and regulations.

Prescribed Attire

Alternate Uniform (white blouse, green pants and vest) and closed black shoes

Service Credit/Compensatory Overtime Credit

DFAs shall be entitled to either Service Credit or Compensatory Overtime Credit (COC), whichever is applicable, in accordance with DepEd Guidelines.

Reports

Monthly and Badgework Reports must be brought and submitted during the scheduled meeting.
