**DIVISION DANCE SPORTS WORKSHOP FOR ELEMENTARY AND
SECONDARY DANCERS SEASON 3**

1. After the successful conduct of the Seminar-Workshop on Institutionalizing Sports Clubbing in the Public Schools pursuant to DepEd Order No. 022, s. 2025 and in support of the Department's thrust to strengthen school-based sports development programs, this Office hereby announces the conduct of the Division Dance Sports Workshop for Elementary and Secondary Dancers Season 3. At the Tagbilaran City Central Elementary School Gym.
2. The dance sessions will run for 15 Saturdays from 8:00-12:00 am and 1:00-5:00 pm to commence on July 25, August 1, 15 & 29 September 5, 12, 26, October 3, 10, 17 & 24 November 7, 21 & 28, and culminates on December 5, 2026. Public elementary and secondary schools may send as many interested and potential pairs in both Latin and modern standard, however schools will only pay 1,200 for Latin and 1,200 for modern standard the rest will be free from the registration of 600 per dancer. As a mandatory requirement all public elementary and secondary schools have already organized Arnis sports clubs in their respective schools and should submit therefore the accomplished and signed Form 1 & 2 as proof of their organization of the Arnis sports club to Ms. Bianca Arcayena the division COS for Sports Clubbing on or before July 24, 2025.
3. A registration fee of Six Hundred pesos Php 600.00 is charged per participant to defray expenses in the payment of the Dance Instructor chargeable against school MOOE and other local funds subject to the usual accounting and auditing rules and regulations of the government.

Teachers who will accompany and facilitate the attendance and active participation of their dancers for the 15 Saturday Sessions are entitled to service credits pursuant to the revised guidelines in granting service credits and compensatory time off (CTO). However, if the Parents of the dancer/s will be the one to accompany them teachers are no long entitled to service credits. Expenses relative to the conduct and participation of the said dance sports workshop are chargeable against school MOOE and other local funds subject to the usual accounting and auditing rules and regulations of the government.
