**DISSEMINATION OF INFORMATION ON THE PISO KOLEKTIV ONLINE
FINANCIAL CITIZENSHIP PROGRAM OF PROJECT KAYAMANAN PHILIPPINES
INCORPORATED**

1. Attached is a communication from **Project Kayamanan Philippines Incorporated** regarding its **Piso Kolektiv**, a free online financial citizenship program intended for interested public high school learners. The organization aims to promote financial literacy and responsible citizenship among the youth.
2. This Office disseminates the information **for the awareness and appropriate consideration** of public secondary schools. Participation of schools and learners shall be **strictly voluntary** and shall be subject to the discretion of the School Head, with the consent of the parents or guardians of participating learners, where applicable.
3. School Heads shall ensure that participation in the program complies with existing Department of Education policies and the following conditions:
 - a. **Instructional time shall not be interrupted or compromised.** Participation shall be scheduled outside regular class hours or at a time that will not adversely affect the delivery of the prescribed curriculum and learning competencies.
 - b. **No registration fee, membership fee, contribution, donation, solicitation, or any form of monetary collection shall be required from learners, parents, teachers, or schools** as a condition for participation, consistent with existing DepEd policies prohibiting unauthorized collections.
 - c. The organization shall observe the provisions of **Republic Act No. 10173 (Data Privacy Act of 2012)** and ensure the confidentiality and protection of learners' personal information. Schools shall secure the necessary parental consent whenever required.

d. Participation in the program shall not involve the promotion or sale of products, services, investment schemes, or any commercial activity within the school.

4. This memorandum **shall not be construed as an endorsement, accreditation, or certification** by the Department of Education, Division of Tagbilaran City to Project Kayamanan Philippines Incorporated or any of its programs. The Schools Division Office merely disseminates the information received from the requesting organization, and each school shall exercise due diligence in determining the suitability of participation.

5. Schools opting to participate are encouraged to coordinate directly with the organization regarding program implementation while ensuring full compliance with existing Department of Education policies on learner welfare, child protection, data privacy, and school governance.

6. Immediate dissemination of and compliance with this Memorandum is desired.
