**INCLUSIVE PATHWAYS: EFFECTIVE INDIVIDUALIZED EDUCATIONAL PLAN (IEP)
DEVELOPMENT AND LEARNER SUPPORT BATCH 1 – GROUP B**

1. In line with the Department's thrust to strengthen teacher competencies in delivering quality inclusive education, the Curriculum Implementation Division (CID) will conduct Day 2 of the training titled *"Inclusive Pathways: Effective IEP Development and Learner Support Batch 1 – Group B"* on August 8, 2026, at Bodare, Dao, Tagbilaran City.
2. The activity aims to:
 - 2.1 demonstrate a comprehensive understanding of the policies, principles, and practices of inclusive education, IEP development, assessment, placement,

 - 2.3 integrate developmentally appropriate, inclusive, and play-based instructional strategies aligned with the Curriculum to enhance learning outcomes;
 - 2.4 promote positive attitudes and demonstrate collaboration, fairness, and support within training activities and school-based implementation, strengthening teamwork with MDTs, school heads, and parents to sustain inclusive excellence.
3. The participants shall be the teacher-advisers of the pull-out learners, as listed in Annex A. Service credits shall be granted to participants in accordance with DepEd Order No. 013, s. 2024, dated September 18, 2024, titled "Revised Guidelines on the Grant of Vacation Service Credits for Teachers".
5. Expenses related to the conduct of the activity, including honoraria, meals, and travel expenses of the Resource Speakers, shall be charged to SNED PSF. Travel and other incidental expenses of the participants shall be charged to local funds, subject to the usual accounting and auditing rules and regulations.
