2026 REGION VII LEARNERS' CONVERGENCE

To: Schools Division Superintendents
Assistant Schools Division Superintendents
All Others Concerned

1. To further strengthen learner leadership and participation in school and community development, the Department of Education Regional Office VII (DepEd RO VII), through the Education Support Services Division, and in partnership with the Schools Division Office of Cebu Province, shall conduct the **Region VII Learners' Convergence 2026** on **September 2-4, 2026**.

2. - c. Division Youth Formation Coordinators (DYFCs) to be part of the Technical Working Committee.

5. Meals and accommodation shall be provided to the participants chargeable against the Regional YFD Funds downloaded to the host division, Cebu Province. Traveling and other incidental expenses related to the conduct of the activity shall be charged against the Division/School MOOE, Local Funds, or Division YFD Funds, subject to the usual accounting and auditing rules and regulations.
6. All participants, including the Technical Working Committee (TWC), shall be granted Compensatory Overtime Credits (COC), as applicable, for their participation on days rendered on weekends and holidays in line with CSC and DBM Joint Circular No. 2, s.2004.
7. The Schools Division Offices, through their Division Youth Formation Coordinators, are required to submit the following on or before Wednesday, August 26, 2026:

 - c. Learners' Consent and Waiver Form;

 - e. Scanned Proof of Insurance for all delegates (with travelling and medical coverage).
