Warm greetings from the Bohol Association of Human Resource Management Practitioners Incorporated (BAHRMPI)!

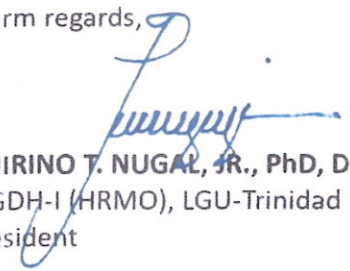
